Love Is Still In The Air

You may recall hearing about Steven Snyder-Hill. In 2011, at the Republican Party Presidential Debate in Orlando, there was a question posted to candidate Rick Santorum by Steve who was then serving in Iraq. He asked whether the candidates' presidencies would "circumvent the progress that's been made for gay and lesbian soldiers in the military." By posing the question, he publicly came out two days after the repeal of the "Don't Ask, Don't Tell" policy. He was booed by the audience, and Santorum stated he would reinstate the ban. Earlier that year, Steve, a Captain in the U.S. Army Reserve, married Joshua Snyder in the Congressional Cemetery at the grave site of their personal hero Leonard Matlovich whose gravestone reads "When I was in the military they gave me a medal for killing two men and a discharge for loving one." Steve and Joshua were plaintiffs in a lawsuit filed by the Servicemembers Legal Defense Network challenging the Defense of Marriage Act and other federal statutes that prevented the military from providing equal protections and support to same-sex marriage. Steve chronicled much of this in his book "Soldier of Change: From the Closet to the Forefront of the Gay Rights Movement." He was a speaker at our annual Veterans Day dinner a few years ago. Happy 12th!!

Another First

Army Reserve Officer Tammy Smith was promoted to the position of Brigadier General on August 10, 2012, the first gay general to serve openly in the U.S. military. She retired as a Major General in 2021, having served as Special Assistant to the Assistant Secretary of the Army. She was married to Tracey Hepner on March 31, 2012 in a ceremony at the Jefferson Memorial in Washington, D.C. Hepner was an officer in the U.S. Department of Homeland Security, and was announced as a personal guest of First Lady Michelle Obama for the 2013 State of the Union Address. They remain active by continuing their long-standing support of military families.



Remembering the U.S. Army's First Gay Active-Duty Marriage at West Point

It was January 2018, and two U.S. Army Captains who met during the "Don't Ask, Don't Tell" era became the first active-duty couple to get married at West Point Military Academy. Captains Daniel Hall, 30, and Vinny Franchino, 26, exchanged vows at the chapel; they were Apache helicopter pilots. They met in August 2009 during Ring Weekend, a tradition when the plebes are allowed to retaliate against the firsties, when Hall was a senior and Franchino was a freshman. They became close as partners in a mentoring program that allowed

seniors to offer instruction to freshmen who were following similar career paths; they remained silent and never shared with anyone else that they were gay. They remained in contact with each other and had their first date in 2012, after the repeal of the DADT ban. Hall was in flight school at Fort Rucker in Alabama, and was deployed to South Korea with his Boeing AH-64 Apache attack helicopter, and Franchino was deployed in Germany and several other countries in Eastern Europe. They grew accustomed to being apart at times. Both are now stationed together at Fort Bliss in Texas.



Local Chicago Lovers

We can't pass up a recognition of love, marriage, and activism without celebrating the union of two Chicago favorites, Patrick Bova and Jim Darby. They have been together since 1963 and were married on June 2, 2014. They have been active in local and national gay veteran and same-sex marriage issues for decades, including founding the Chicago Chapter of AVER (originally called GLBVA) and being involved with the Servicemembers Legal Defense Network to overturn the "Don't Ask, Don't Tell" policy. They were also lead plaintiffs in Lambda Legal's lawsuit seeking marriage for same-sex couples in Illinois. Thousands of same-sex marriage licenses have been issued in Cook County since their marriage; they continue to be role models for generations of LGBTQ

individuals in Illinois and across the nation. Jim just celebrated his 91st birthday in February, and Patrick will celebrate his 85th birthday in June, so we joyfully celebrate their amazing pride, resilience, and duty to this country. In 2014, they were invited to the White House to introduce President Barack Obama



during the LGBTQ Pride Month reception.



- Housing: Eviction Defense; Security Deposit Disputes; Co-Owner Disputes; Foreclosures; Property Taxes; Title Correction; Landlord/Tenant Disputes; Building Code Violation Defense; Landlord-side Evictions o Qualifications: The veteran must reside in or have the dispute in Cook County.
- End of Life Planning: Last Will and Testament; Power of Attorney; Living Will Declaration; Illinois Transfer on Death Instrument
 - Qualifications: The veteran must be an Illinois resident.
- Consumer Disputes: Consumer Fraud; Elder Financial Abuse; Collections
 - Qualifications: The veteran must reside in or have the dispute in Cook County.
- **Simple Divorces**
 - o Qualifications: The veteran must reside in or have the dispute in Cook County. The divorce must not involve minor children or jointly owned real property.
- Adult Guardianship
 - o Qualifications: Must seek guardianship over a person, not an estate. The individual that that guardianship is sought over must reside in Cook County.


