#### **Veteran Unemployment**

In August 2023, the veteran unemployment rate was 3.6%, up from 2.8% in July, 2.7% in June, and 2.4% in the previous year. In comparison, the non-veteran unemployment rate was 3.7%, up from 3.4% in July, and 3.6% in the previous year. Rates vary by a number of factors. For example, the unemployment rate for veterans ages 18-24 decreased in June, from 6.9% to 6.5% while the rate for veterans ages 25-34 increased from 1.8% to 2.1%; the unemployment rate for veterans ages 65 and older decreased in June, from 4.4% to 3.5%. The unemployment rate for female veterans was 2.1% in June, which is lower than that for non-veterans, at 2.8%. Likewise, the unemployment rate for Black/African American veterans was 2.5% in June, which is lower than that for non-veterans, at 6.3%. ## **Seeking Honorable Discharges**

A new, class action, lawsuit was filed in San Francisco federal court in August seeking to force the U.S. Department of Defense to upgrade veterans to honorable discharges and remove their sexual orientation from military paperwork. As many of 35,000 veterans who were barred from serving in the military because of their sexual orientation were dishonorably discharged under the "Don't Ask, Don't Tell" (DADT) policy. About 14,000 veterans were discharged from the military under DADT, but more than 20,000 others were also discharged since 1980. The Department of Defense has partnered with the Department of Veterans Affairs for greater outreach to inform veterans of the procedures to update their records but the process is complex, can take vears, and often requires hiring an attorney. The lawsuit seeks a comprehensive review of the process.

## **UK Strategy for Veterans**

The British Government set out a "Strategy for Our Veterans" in 2018 with a ten-year vision for veterans and their families to transition back into civilian life. The plan outlined an approach to improve services for veterans and their families as they transitioned out of military service, gather data to better serve the veteran community, and fully recognize the contributions that veterans have made to society, including those who were challenged by negative stereotypes, like LGBTQ+ servicemembers. An updated report was issued in August that included a review on the impact of the ban of LGBT personnel serving in the military before 2000, the specific challenges that women face upon the transition to civilian life, the establishment of hundreds of housing units to combat veteran homelessness, and a strategy to boost employment of veterans. Perhaps our VA needs to review it!!

# **Drag Performances on Military Bases**

The August issue of the *Modern Military Magazine* was dedicated to the history of drag performances on military bases, and the implications and consequences of the Pentagon's decision on LGBTQ+ protections and the ban on drag shows: https://modernmilitary.org/. This reminds me of similar policies during "Don't Ask, Don't Tell" when gay pride month couldn't be acknowledged or celebrated, and the gay flag was banned from being posted. We see again attacks for true equality and inclusion, and the freedom to celebrate who you are. These bans also fail to recognize that drag shows provide a unique venue for troops to decompress during a time of stressful conflict, as in the World War II-era shows hosted by the USO and American Red Cross. During WWII, Irving Berlin helped to create these shows for the troops with an all-soldier cast in the 1942 stage production "This is the Army." These productions were a huge fundraising success at New York's Broadway Theater, and led to a 1943 film production with Ronald Reagan and George Murphy. Performances were promoted by Hollywood as "normal male soldiers doing their duty to entertain their peers and promote good morale amongst the troops." It also provided a safe space and cover for members of the gay community to serve. These drag shows were prevalent, not only in WWII for U.S. troops, but worldwide, and in other wartime venues. In the First World War, every single division in the Canadian and British Expeditionary Forces would have had a female impersonator as part of their concert troupe. Some drag performers, like Perry Watkins, were openly gay, and reenlisted several times and was promoted to Sergeant First Class and honorably discharged, after challenging the Army in a lawsuit.
